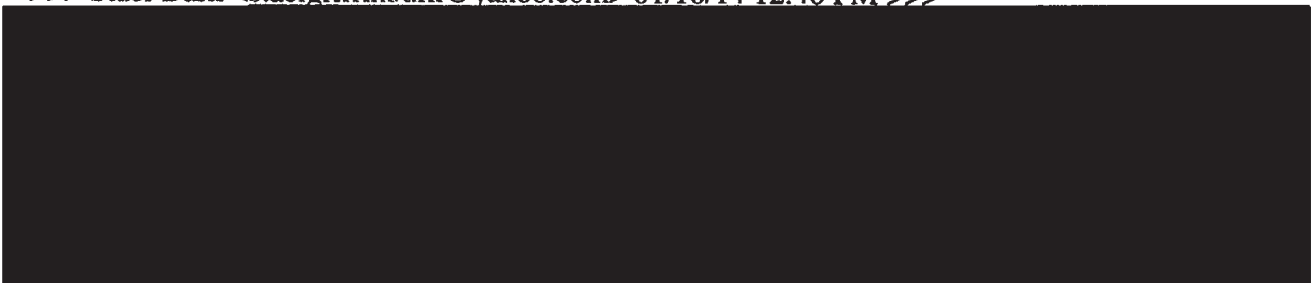
I understand. I would be frustrated the same if I were in your shoes. I think the AGs office probably should have sent you an email copy simultaneously with Susan at least.
