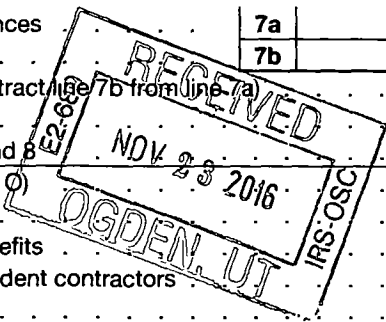



The Gilbert Education Foundation was founded in 2001 as a 501(c)(3) non-profit organization to raise funds for programs that enhance the educational opportunities of Gilbert Public Schools (GPS) students and educators. Our mission is aligned with the needs of the GPS district, but we are a separate entity with our own board of directors and staff. We comply with the IRS rules and regulations to retain our tax exempt status as a 501(c)(3) organization. Our board is made up of business leaders with large national and regional corporations such as Orbital ATK, Dignity Health and other midsize local architecture, construction and electrical firms.

Over the last 15 years we have raised and contributed nearly \$750,000 to students, staff and programs in GPS. We do this through the following programs:

Classroom Innovation Grants -- To help alleviate the district budget constraints, we fund extra unique learning opportunities for the students that might not otherwise be available to them. Educators apply for grants up to \$1,500 to fund equipment such as 3D printers and other pieces of technology, cutting-edge specialized curriculum programs and other innovative needs that impact as many students as possible.

Scholarship Program - Each spring the Foundation awards high school seniors college scholarships and educators funding for their professional development.

S.T.E.M. Education - To increase STEM education within the district GEF, looks to partner with businesses to help fund programs such as Project Lead the Way which is an extensive Science, Technology, Engineering and Math curriculum (STEM). Funding is granted for programs that fall under this category as our budget permits.

Varsity Letter Volunteer Program - Part of our foundation goals is to build a stronger community. Our varsity letter program encourages GPS students to volunteer throughout the community. For every 200 hours of volunteer time, they are eligible to receive a varsity letter. This provides an avenue for students to earn a letter other than through academics or athletics and gives them valuable experiences.

Social Services -- This is an area that often sets us apart from other education foundations and is an area that GEF feels makes us different in a positive way. Each year we partner with United Way during their annual campaign at GPS and ask the employees of the district to donate to our foundation. With this money we are able to help the families of the district as well as the employees during emergency times of need with food, clothing, day care and utilities. We are able to do this quickly without a lot of red tape and help these people get over a rough patch and get back on their feet.
